It also gives you the opportunity to apply for Festival tickets prior to the general public, after the ballots for Festival Society Members and Associate Members have taken place. Inclusion on the Festival Mailing List does not guarantee tickets, however it does increase your chance of securing seats. Please note that a maximum of two standing places per production may be applied for.
